60° Blade Recommended



Cut this material in mirror image



150°C - 160°C



2.0 - 3.0 bar Medium pressure



8-12 seconds



Peel Warm/Hot



Wash cold (40°C) inside out. NOT suitable for Tumble Dry. NOT Suitable for Dry Cleaning.



Layering not recommended



Iron inside out. Do not iron directly onto transfers



Suitable for cotton, mixtures of polyester/ cotton and polyester/ cotton blends



Application Tape not required.



Heat sublimation paper on top of already pressed vinyl at 195°C for 30 seconds
