11. TOXICOLOGICAL INFORMATION

11.1 Information on toxicological effects

Acute toxicity Information available for the product:

This product is expected to be of low toxicity. Based on available data, the classification criteria are not met.

Ingestion of large quantities may result in nausea, vomiting, abdominal pain and diarrhoea.
