SECTION 4: First aid measures

4.1 Description of first aid measures

General Information: Symptoms of intoxication may even occur after several hours. It is recommended to continue

medical observation for at least 48 hours after the incident. Provide fresh air. If breathing is irregular or stopped, administer artificial respiration. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator. If medical advice is needed, have product container or label at hand. If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing.

contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE,

doctor or physician.

Ingestion: Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious

person. Get medical attention or advice if you feel unwell.

4.2 Most important symptoms and effects, both acute and delayed

Inhalation: May cause allergy or asthma symptoms or breathing difficulties. Inappropriate handling may cause

formation of dust or aerosols which may induce sensitization and may cause allergic reactions in

sensitized individuals.

Skin contact: Causes irritation.

Eye contact: Causes severe or permanent damage. **Ingestion:** No known effects or symptoms in normal use.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Do not breathe dust or vapour. Wear eye/face protection. Repeated or prolonged contact:. Wear suitable gloves.

Dilute with plenty of water. Do not allow to enter drainage system, surface or ground water. Do not allow to enter the ground/soil. Inform responsible authorities in case undiluted product reaches drainage system, surface or ground water or the ground/soil.

6.3 Methods and material for containment and cleaning up

Ensure adequate ventilation. Dyke to collect large liquid spills. Warning: concentrated enzymatic product. Spillages should be removed immediately to avoid formation of dust from dried product. Use a cloth wetted with a chlorine bleach to clean up product spillage. Flush remainder carefully with plenty of water. Avoid splashing and high pressure washing (do not remove product spillage in procedures likely to give rise to aerosols).
