## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia and is available at all times. Have this MSDS with you when you call.

**Inhalation:** If exposed, remove victim to fresh air. Recovery is rapid after removal from exposure. Seek medical attention if irritation persists or breathing difficulties arise

**Skin Contact:** Remove contaminated clothing and wash thoroughly with soap and water. Seek medical attention if irritation develops. Launder clothing before reuse.

## Section 6 - Accidental Release Measures

**Spillage:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

**Handling:** Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

**Storage:** Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Ensure containers are labelled, protected from physical damage and sealed when not in use. Keep from extreme heat and open flames and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Bagged fertilisers should be stored under cover and out of direct sunlight

## Section 8 - Exposure Controls and Personal Protection

The exposure value at the TWA is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. A TWA has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. **Environment:** Avoid contamination of waterways. Fertilisers, particularly those containing nitrogen and phosphorus can stimulate weed and algal growth in static surface waters. Nitrogen fertilisers can also contain or form Nitrate which can contaminate surface and ground water. High nitrate concentrations may render the water unsuitable for human and livestock consumption.

**Ecotoxicity effects:** Dissolves slowly in water. Harmful to aquatic life
