## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. **Inhalation:** If mists have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists for more than about 30 minutes, seek medical advice

**Skin Contact:** Wash affected areas with water until chemical is removed. Remove all contaminated clothing and launder before re-use. If in doubt obtain medical advice.

## Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. ## Section 7 - Handling and Storage

**Handling:** Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. **Storage:** Store in a cool, dry place away from children and animals or foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Store away from farm chemicals e.g. insecticides, fungicides and herbicides. Containers should be kept closed in order to minimise contamination. Keep from extreme heat and open flames, and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10.

*Exposure limits have not been set for any ingredients in product. The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.*

### Personal Protection
