PRODUCT USE	DILUTION RATE	APPLICATION
Prespray, sanitiser, odour suppressor & deodouriser	Normal Soils: 25ml/L of water Heavy Soils: 200ml/L of water	Spray evenly over carpet with atomising spray. For heavy soiling agitate carpet fibre. Allow to react for 10 to 15 minutes before extracting
Prespotter	Normal Soils: 200ml/L of water	Apply to stain. Gently agitate working from the edge of the stain towards the centre. Soak with dry cloth or extract.
