Diluted ratio 1:4, and up to 10 parts of water for light maintenance. Spray onto the surface to be cleaned and agitate with a soft brush or cleaning cloth. Allow to sit on the surface for as long as possible without drying and then rinse thoroughly with large amounts of water. All detergents have an effect on the environment. Always use the correct dose for maximum efficiency and minimal environmental impact.
