#### **DIRECTIONS:**

Add 30 gms (1 1/2 table spoons) per 2 litres of water. Pre-soak tableware & glassware for 10 minutes (the longer the better) before manual washing or auto dishwashing.

- Pre-soaking and destaining dishes and cutlery, pots and pans and glassware like mugs, teacups and even beer glasses.
