DESCRIPTION:

Green Rhino® Fabric Softener is a commercial strength fabric softener that leaves clothes, linen and other fabrics feeling soft & fluffy. It is a concentrated formula so you can just add a little to your wash for soft clothes with a clean fresh fragrance.

DIRECTIONS:

- For outstanding results we recommend use in conjunction with fragranced Green Rhino Laundry Detergent (GRL1).
- Do not pour undiluted Fabric Softener directly on to clothes. Use dispenser or dilute fabric softener in water first.
- Do not use on microfibre fabrics.
- Always follow the washing instructions of the fabric.

SUGGESTED DOSAGE RATES:

Top and front loading machines:
Regular load: 35mls per load.
8 mls/kilo for commercial use.

Handwashing: Approximately 10 mls per 8 ltrs of water.

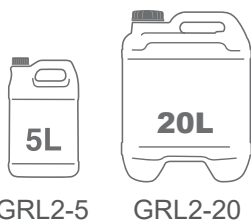
