CITRUS CLEANER

TECHNICAL DATA SHEET

DESCRIPTION:

Green Rhino® Citrus Cleaner is a concentrated cleaner with added D-limonene (processed orange peel) to be used for the cleaning of dirt, grease and grime.

DIRECTIONS:

Always check first for colourfastness by testing in an inconspicuous area. Use water to dilute the Citrus Cleaner and then apply the diluted solution to the area to be cleaned so that the dirt is penetrated. Agitate the surface with a brush, rag or sponge before rinsing off with water. Do not allow Citrus Cleaner to dry on the surface.

Dilution Rate

- 1: 2 Water: heavy cleaning
- 1:10 Water: medium cleaning
- 1:20 Water: light cleaning

- Floors, stoves, benches, baths, showers and toilets
- Tyres, wheels, under bonnets, engines etc.
