5. Fire-fighting measures

Extinguishing media	In case of fire, use carbon dioxide, dry chemical, foam, water fog.

Precautions for Firefighters	The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases.
