DIRECTIONS:

Shake well before use. Dispense onto a cloth or applicator pad. Start and finish, one section at a time. Use small amounts and rub in a circular motion. Allow to touch-dry. Wipe (buff) off residue with a soft towel. For best results follow up with a wax.

Removes oxidation scuff marks and scratches on paintwork
