

## DESCRIPTION:

**Multi Purpose Cleaner** is a heavy duty alkaline detergent formulated to remove dirt, grease and grime. It is ideal for automotive, commercial and domestic cleaning.

## DIRECTIONS:

Always check the surface first for colourfastness by testing in an inconspicuous area. Use water to dilute and then apply it to the area to be cleaned so the dirt is penetrated. Agitate with a brush, rag or sponge before rinsing off with water. Do not allow Multi Purpose Cleaner to dry on the surface. Works best on cool surfaces.

## Suggested Dilution rates:

**1 part Multi Purpose Cleaner to 2 parts water:** Engines, Engine Bays, Wheels, Wheel arches, mud flaps, Door jambs, Floor mats and exterior vinyl.

**1 part Multi Purpose Cleaner to 10 parts water:** Carpets, Fabric, Upholstery and interior vinyl.

**1 part Multi Purpose Cleaner to 20 parts water:** Cleaning delicate surfaces.

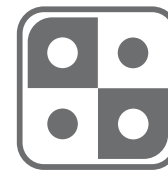
