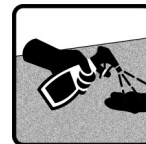

Application

Task	Method	Dilution
Carpet	1. Blot area working from the outside edge of the stain towards the centre. Blot residues with a clean white towel to rinse, or extract to remove residue.	Use Neat (undiluted)
Pen Graffiti	1. Test in an inconspicuous area to ensure surface compatibility. 2. Apply and immediately agitate with cloth or brush and wipe off.	Use Neat (undiluted)
Clothing	1. Prior to laundering apply to collars, cuffs, grease and ink stains then launder in the normal manner.	Use Neat (undiluted)

IMPORTANT: Always test fibre compatibility prior to use.
