#### Section 6. Accidental Release Measures

## **General Response Procedures:**

Clear area of all unprotected personnel. Allow only trained personnel wearing appropriate protective equipment to be involved in spill response. Contain spill, avoid accidents, clean up immediately. Increase ventilation.

#### **Environmental Precautionary Measures:**

Prevent run off into drains and waterways. If contamination of sewers or waterways has occurred advise the Environmental Protection Authority and/or your local Waste Authority.

#### **Clean Up Procedures:**

Mechanically collect as much of the spill as possible. Absorb with sand, earth or clay. Transfer to suitable, labelled containers and dispose of promptly as hazardous waste as per Section 13. Spill on areas other than pavement (e.g. dirt and sand) may be handled by removing the affected soils and placing in approved containers. Wash area down with water and collect washings for disposal.
