## Section 4 - First Aid Measures

## General Information:

Rigid polyurethane begins to degrade at 250°C and Flash Ignition Temperature is about 310°C. The degradation products include the isocyanate monomer (MDI, or methylene diphenyl isocyanate), the corresponding amine (MDA, or methylene dianiline), carbon monoxide and HCN. The release of carbon monoxide and cyanide is degradation temperature-dependent. The co-exposure to HCN and carbon monoxide show synergistic rather than additive effect in the toxicity of the smoke in a rat model. If the experimental polyurethane samples were proofed with flame retardants, the toxicity of smoke was slightly diminished or remained unchanged.

#### Section 6 - Accidental Release Measures
